AN ESTIMATED 105,959 PEOPLE VIEWED PRE-RECORDED PERFORMANCES AND RECITALS DISTRIBUTED ONLINE. A TOTAL OF 55,341 PEOPLE ATTENDED 33 PERFORMANCES AT MCCAW HALL. AN ESTIMATED 170,000 OF LISTENERS TUNED IN TO LIVE PREVIEW AND PERFORMANCE BROADCASTS THROUGH ITS ONLINE OPERA CHANNEL, AND ON INDEPENDENT RADIO STATION CLASSICAL KING FM 98.1, BROADCASTING FROM THE SEATTLE OPERA CENTER.
