

RELEASE OF LIABILITY, INDEMNITY, HOLD HARMLESS, MEDICAL AUTHORIZATION, and PHOTOGRAPH/RECORDINGS RELEASE FORM

PLEASE READ CAREFULLY

The following is a release and indemnity agreement which is required of all persons participating in activities of Seattle Opera's Artistic Collaborative Event with Angelina Villalobos. All participants must complete this form, sign it (including signature of a parent or guardian for any participant under 18 years of age), and return it to SEATTLE OPERA. Those who do not have a completed form on file will not be permitted to participate in SEATTLE OPERA activities.

I hereby state that I wish to participate in the activities offered by SEATTLE OPERA. I recognize that any group activity may involve some risk, and I assume all risk of participation. I understand and agree that without the protection which this agreement provides for the assets, directors, officers, leaders, employees, coaches and agents of SEATTLE OPERA, SEATTLE OPERA would not be able to offer activities to participants.

I agree to respect and abide by the rules of SEATTLE OPERA that are provided to me or explained to me as a condition of my participation in any particular activity. By way of example, and not by way of limitation, I agree to abide by the rules of Seattle Opera during my participation in Seattle Opera Artistic Collaborative Event with Angelina Villalobos. I am responsible for making myself aware of these rules. I agree to be courteous to other participants and to the SEATTLE OPERA directors, coaches and staff and to follow their reasonable instructions. I understand and agree that I may be suspended from participation in SEATTLE OPERA activities if I break the rules or fail to follow reasonable instructions.

In consideration of the right to participate in the activities offered by SEATTLE OPERA, I agree to RELEASE, HOLD HARMLESS AND INDEMNIFY SEATTLE OPERA, its directors, officers, leaders, employees, coaches and agents from any and all liability, claims and causes of action arising out of or in any way connected with my participation, or the participation of any minor on whose behalf I am signing, in any activities offered by SEATTLE OPERA. I personally assume all risks in connection with these activities. If I am signing on behalf of a minor, I further agree to HOLD HARMLESS AND INDEMNIFY SEATTLE OPERA, its directors, officers, leaders, employees, coaches and agents from all liability, claims and causes of action that the minor may have arising from the minor's participation in activities of SEATTLE OPERA.

I, as a parent of a minor engaged in activities of SEATTLE OPERA, hereby authorize the adult coaches, directors and officers of SEATTLE OPERA to consent to emergency medical treatment by any licensed physician in the State of Washington for my child when such treatment is deemed necessary by such physician and when I cannot be reached within a reasonable time at phone numbers I have supplied above.

I understand that this authorization is given in advance of any specific diagnosis, treatment, or hospital care being required, but is given to provide authority for such services or procedures as the physician in the exercise of his or her best judgment, may deem advisable. I give permission for a Seattle Opera Artistic Collaborative Event with Angelina Villalobos Staff Member to transport my child to an appropriate medical facility in the event of an emergency.

I know of no mental or physical problems, which might affect my ability or my child's ability to safely participate in SEATTLE OPERA activities. I agree to be responsible for any medical or medical-related charges in connection with my child's participation in SEATTLE OPERA activities.

I certify that I have/my child has sufficient accident/medical insurance coverage for any reasonably probable contingency.

I hereby grant permission to SEATTLE OPERA and Seattle Opera Artistic Collaborative Event with Angelina Villalobos to use photos and all work created or produced through SEATTLE OPERA/Seattle Opera Artistic Collaborative Event with Angelina Villalobos. I acknowledge that my name, image, words, and/or voice ("persona") might appear in printed or electronic materials, photographs, sound recordings, and audiovisual works, such as videos ("materials"). I assign SEATTLE OPERA/Seattle Opera Artistic Collaborative Event with Angelina Villalobos all rights in using such materials for promotional or educational purposes.
